



# Artist Application

## Rules and Regulations

**DATES & TIMES:** Friday, October 27, 2017, 6:00 – 11:00 p.m. & Saturday, October 28, 2017, 4:00 – 11:00 p.m.

**DESCRIPTION:** Owl-O-Ween is a Hot Air Balloon Family Friendly Festival featuring Live Entertainment, Hot Air Balloon Glows, Trick-or-Treating (at the balloons), Multiple Stages, Tethered Balloon Rides, Artist Alley, Costume Showdown, Roving Performers, Merchant Marketplace, Food Court, Interactive Kids Zone and so much more!!!! [www.owl-o-ween.com](http://www.owl-o-ween.com). Anticipated attendance is 45,000.

**LOCATION:** Kennesaw State University Sports + Entertainment Park, 3200 George Busbee Pkwy, Kennesaw GA 30144. Located just 20 miles north of downtown Atlanta, and less than 1 mile from both I-75 and I-575.

**FEES/REFUNDS/WAITLIST:** Non-refundable Jury/application -\$25.00. Booth Space: 10 X10 - \$200.00, 10X20 \$400.00. A \$50 charge will be assessed for all returned checks. **Make Checks Payable to: CES.** Jury checks will be deposited when the application is received. Booth checks will be deposited around August 15, 2017. Artists placed on the waitlist will be notified via email. As space becomes available, artists will be pulled from the waitlist based on “like art” from vacated space. The event will be held rain or shine. In the event of inclement weather, the festival management team will make the final determination of continuance of the Festival. Refunds will not be issued after August 31, 2017.

**DEADLINE/NOTIFICATION:** August 3, 2017. Notification by August 18, 2017.

**ACCEPTED CATEGORIES:** All items must be hand crafted by the artist. Resale or wholesale items (buy/sell) *are not* permitted. Accepted categories include jewelry, pottery, glass, painting/drawing, photography & digital media, textile/leather, metal, wood, mixed media and other hand crafted items. Artists may only show and sell work from the category in which they have been accepted. Artwork and booth submitted in photos must be representative of display and art offered for sale. Festival organizers reserve the right to ask the artist to remove items not representative of art submitted for jury process/acceptance.

**APPLICATION PROCESS:** Submit signed application, jury/application check and booth check (must be separate checks), 5 photos (4X6 only), one photo of the studio or workstation (tools, supplies, work area should be seen), one of the outdoor booth display and three photos of the individual art pieces and a self addressed stamped envelope. Accepted artists understand and agree that the show promoter may use images of their work for the sole purpose of marketing the event.

**ARTIST:** The artist must arrive on time and stay for the duration of the festival. Artists may not open their booth late or close early. No agents, dealers, or representative may attend in place of the artist. Only one artist may display in a booth unless the work produced is a collaboration of two artists. Artists may bring 1 additional helper.

**THEME:** Artists are encouraged to get in the Halloween spirit, and dress up (designed for the young children, nothing gory or scary) and Trick out your booth. You may also hand out candy to Trick or Treaters.

**BOOTH:** Booth size is 10X10, 10X20. All booths are located on concrete and tent weighting is mandatory! Artists must furnish their own tent, display tables, skirting, & chairs. All displays must be designed and constructed to be aesthetically pleasing, and all sales and promotional activities must be confined to artist’s assigned space. One 20-amp outlet will be provided to each booth. The artist must provide the extension cord and appropriate lighting for the booth. Additional lighting is absolutely necessary.

**PARKING:** Artists must park in the free artist parking (trailers and vehicles) area.

**SET UP/TEAR DOWN:** Set up is October 26 or 27, 2017. Artists can select set up time and will be required to unload within a 30 minute window and remove their vehicle. Booths must be fully operational by 6:00 p.m. on Friday and 4:00 p.m. on Saturday. Tear down can begin at 11:00 p.m., however vehicles are not permitted in the area until festivals guests are gone and the area is secured for vehicle traffic.

**NO:** Pets, smoking or firearms.

**SECURITY:** The Festival will be provide overnight security. Neither Owl-O-Ween, nor any of the event producers are responsible for any items left on-site.

**NO GUARANTEE OF RESULTS:** The Owl-O-Ween Hot Air Balloon Festival and its organizers do not warrant or guarantee any particular results of the Festival, nor does it guarantee a particular number of attendees or exhibitors.
